 - Criminal convictions, where noted, are based on public records but users should verify independently.

We may share information with:

- U.S. law enforcement agencies (FBI, local police)
- Canadian law enforcement (RCMP, provincial police)
- International law enforcement (Europol, Interpol, etc.)
- Child protection agencies worldwide

When required by:

- Valid legal process or court order
- Threat to public safety or child welfare
- Prevention of ongoing abuse
- International mutual legal assistance treaties

We encourage all survivors to report abuse directly to law enforcement in their jurisdiction. Our role is to provide information and support accountability, not to replace formal criminal investigations.
